### **New committee for Friends of Glenlee Inc**

Thanks to everyone who attended our AGM on 31 July. A new committee was elected, with most members continuing on.

The new Committee is:

- \* President – Brian Ralston
- \* Vice-President – Sue Emmett
- \* Secretary – Linda Simon
- \* Treasurer – Caroline Hart
- \* Ordinary members: Susan Ghosn, Matthew Allison, one vacant position

In the discussion on campaigning to preserve Glenlee, the following points were made:

- \* the need for Council to take further steps to acquire Glenlee and to set aside funding to do so. We would pursue funding for the Peakhurst Hub;
- \* while Council had been unanimous in support of Glenlee, it had taken no action. It was agreed that Council should pursue grants. Friends of Glenlee should be part of the meeting with the Environment Minister;
- \* the Minister should be asked to enact the Act to allow access to the Glenlee site.

**It was also agreed that the Friends of Glenlee complete a form nominating Glenlee as a national park.**

### **Letter from the State Minister for the Environment to Georges River Councillors**

While we have had no response from the Minister for the Environment (see advocacy from Mark Coure below), the Minister did write to all Georges River Councillors. Her letter is attached.

The letter is disappointing in many ways, but she does make the point:

“... I am working with Heritage NSW to consider what options exist for the heritage protection of Glenlee. I am keen to discuss this with Georges River Council and as such, I will be writing directly to the Mayor and interested councillors to request a meeting.

I will be asking the Council to work together with me to develop an ongoing, long term solution for Glenlee. This is not something Government can do alone. I know there are many Councillors – including yourself (this was directed at Councillor Ash Ambihaipahar, who wrote the letter that led to this response) – keen to work with Government to solve this issue.”

### **State Member Mark Coure continues advocacy for Glenlee**

State Member for Oatley Mark Coure has again written to the Environment Minister Penny Sharpe, asking her to “urgently intervene to ensure Glenlee can become public space for the community.” He asks her to “continue liaising with your Federal Parliamentary colleagues to ensure that this land can be acquired for the community to enjoy...The preservation and protection of Glenlee for current and future generations is vitally important for our community,” he says. He also asks for an update on our request to meet with her.

Friends of Glenlee have still not had any response to our request for a meeting from either the state Minister for the Environment, Penny Sharpe, or the Minister for Aboriginal Affairs and Treaty, David Harris. Please keep up the pressure and write another email or letter to them. See details below.

### **What happened at Council last week**

Councillors Mahoney and Ambihaipahar put forward a resolution at Georges River Council meeting on 24 July. It was carried and asked Council to:

- \* investigate and seek advice on Glenlee’s eligibility as a “Community Acquisition Proposal” to be incorporated into the NSW National Parks system;

- \* ask the Minister for the Environment to authorise access to Glenlee under the Heritage Act, 1977, by Council officers and/or its appointed consultants for the purposes of carrying out any inspections deemed necessary to assess the site for Aboriginal and natural heritage;
- \* prepare a briefing note which provides options for possible future uses of Glenlee prior to meeting with the Minister:
- \* consult with Friends of Glenlee, Oatley Flora and Fauna Conservation Society and local bush care and relevant community groups when developing the briefing note.

### **Sign the Save Glenlee petition**
