# INTERACTIONS OF MAMMAL AND REPTILE PREDATORS

An audience of 40 watched Brendan Alting present results from his PhD project into interactions between dingoes, an apex predator, and 3 mesopredators – quolls, foxes and goannas. Apex predators, such as dingoes, can exert strong influences on smaller predators, suppressing their numbers, benefitting smaller species in different ways.

Brendan is a final year PhD Student at the University of New South Wales and an OFF research grant recipient. Brendan's work is part of the Myall Lakes Dingo Project, ongoing on the mid-north coast of NSW since 2019.

As part of the project Brendan set up camera traps so he could identify the number of different species in the research area . This resulted in more than a million images, not necessarily all of animals, which had to be checked and identified. Artificial Intelligence was used to assist in this process reducing the amount of work needed.

One of the project aims is to improve dingo management through collaboration with local residents, national parks, indigenous groups, and council. This includes educating the public to understand dingo behaviour and especially to not feed them. This research indicated that the pure-bred dingoes in the area seem to coperate within a number of defined ranges.

The non paddlers enjoyed a walk along the river and saw the planting along the riverbank which was done in November. Some of the eucalypts are now more than a metre high! The river-bank restoration was started by lan approx. 35 years ago and it is fabulous to see the resultant beautiful big trees.

The walkers also continued on to the Bong Bong Weir just past the picnic area. Both groups met at Cecil Hoskins Nature Reserve for a picnic lunch.

Glenlee has been sold to persons as yet unknown. Until a DA is submitted the property remains as is and is not yet regarded to be in imminent danger. This was the "trigger" mentioned by the Minister for Environment and Heritage, Penny Sharpe, needed to invoke another NSW State Interim Heritage Order. Locals and others concerned about the fate of Glenlee should be forever vigilant for any undue developments – such as an excavator or other plant or equipment being moved onto the property. # GEORGES RIVER BIODIVERSITY AND FORESHORE STUDIES (LEP2021) - FSPA REVISITED) - OUTCOMES

GRC's draft planning proposal for changes to the Georges River Local Environment Plan 2021, after passing through Council's Environment and Planning Committee, was put to the full March Council meeting. In essence it maintained all the minimum lot sizes for subdivision as they were in the former Foreshore Scenic Protection Area (FSPA) back in 2020 as well as reasonable floor space ratios (FSR) and landscaped areas (percentages) across the Foreshore Scenic Protection and Unique Character Areas (UCA) as well those lots that were previously in the FSPA but were then excluded under the previously proposed plans. In total, there were over 320 submissions to the consultation: 293 individual submissions from the community, and 30 community submissions based on a proforma. In addition, of 178 responses to the lot size poll, 83.4% were in favour of keeping the existing minimum lot size for subdivision. A win for the environment through participatory democracy? Many, many people had or took an interest in the proposals and made submissions. Ultimately, we believe these are what influenced Council's decisions: ie, the community's strong views, supported effectively by the current Councillors. OFF would like to thank Councillors Borg, Jamieson, Landsberry, Mahoney and Mort, who promised to advocate to save the FSPA in their Responses to OFF's candidate survey.

Further, to mitigate the potential for these resolutions to be impacted by Premier Minns' Sydney densification push that could result in relaxation of allowable developments in Council's LEPs, the following recommendation was also adopted by Council:

# **Exclusion from Complying Development**

Request the Department of Planning, Housing and Infrastructure (DPHI) to exclude the application of the Low-Rise Housing Diversity Code from the proposed FSPA and proposed UCA to ensure dual occupancies, manor houses, multi dwelling housing and terraces are only permitted through the Development Application process.

## MEMORIAL TO SHARYN CULLIS

OFF is proposing to establish a memorial for Sharyn Cullis, a well-known and illustrious member of OFF and avid campaigner on environmental issues, who tragically passed away in 2022. Prominent among these were the establishment of Dharawal National Park, protection of our vulnerable Koala populations, particularly in western Sydney, caring for the Georges River and assisting OFF in its endeavours.

Sharyn was the long-time Principal of the Georges River Environmental Education Centre, founder and Secretary of the Georges River Environmental Alliance and long-time community representative on the Georges Riverkeeper Committee. In recent years she received her PhD, focusing on the effects of coal-mining on the water catchments south of Sydney supplying up to 25% of Sydney's water supply. This was another of her passions. She was also at the forefront of Oatley residents' concerns about the effects of GRC's planning proposals in the preceding article.

The <u>Council's Historical Markers</u> program is one way to achieve this. Nominations close on 19<sup>th</sup> May. Members are urged to nominate Sharyn, a lifelong dedicated voice for the natural environment. Information available:

#### SYDNEY BASIN KOALA PROTECTION

The Sydney Basin Koala Network (SBKN) attended the recent NSW Koala Summit held as part of the process of reviewing the NSW Koala Strategy, with the aim of gathering thoughts and ideas of members prior to making a submission to the review. Following this seminar SBKN released a progress report, *State of Koalas in the Sydney Basin: First Annual Assessment*, containing new scientific insights from Biolink and a legislative review by EDO. SBKN believes that the current strategy to avoid Koalas becoming extinct by 2050 is not working and made recommendations. SBKN has provided a submission guide to its members: NSW Koala Strategy Review Submission Guide for the Sydney Basin, which can be viewed here.

# 15 April – Fungal Biodiversity - Ecology, Diversity and Distribution

Vanessa McPherson and Michael Gillings are members of the Environmental Microbiology and Molecular Analysis (EMMA) Laboratory in the School of Natural Sciences, at Macquarie University. This laboratory concentrates on the origins and dynamics of genetic diversity, and how such analyses can inform conservation, health, environmental management, and evolutionary biology. Most of the core work in the laboratory examines microbial diversity in various environmental compartments. They have used molecular techniques to investigate a range of organisms, from marsupials and insects, to native and agricultural plants; down to fungi and bacteria in soil or water.

# MEETING WITH FEDERAL MEMBER DAVID COLEMAN.

OFF President, Kim Wagstaff, and Vice-President, Adrian Polhill, recently met with MP David Coleman. After canvassing some federal issues including desperately needed action on the climate emergency faced by all Australians, we put local issues to David for any assistance he could provide. We, and David, considered the most likely chance of securing Federal assistance in our local area would be for other OFF priority issues such as programs/projects that focussed on improving the health of the Georges River. In this case, these might be: **1.** Renovation of Lime Kiln Bay wetlands to improve not only aesthetics but also water quality flowing to Georges River; and **2.** Construction of additional Gross Pollutant Trap/s (GPTs) to

capture and remove rubbish from stormwater drains before flowing under the golf course and into the River's mangroves. The need for this work was clearly evidenced at our recent Clean-up Australia Day event at this location.

# LITTLE PENGUINS OF EDEN

OFF member Chris Lloyd has for some time been involved with a project to conserve the Little Penguins of Twofold Bay with an aim to bring back a thriving colony for years to come.

Eden was once home to a thriving little penguin colony that held a special place in the locals hearts. The penguins faced challenges with predators, as

well as habitat erosion. These factors caused a significant decline in the penguin population, ultimately leading to the colony's extinction by the early 1990s. The Eden community was devastated by the loss and rallied together to raise funds in the hope of resurrecting the penguin colony. These funds remained in the Eden Fairy Penguin Fund until 2016 when Wendy Noble, Ranger from



National Parks & Wildlife Service, Nicholas Carlile, Senior Research Scientist and Chris Lloyd from Southern Ocean Seabird Study Association resurrected the project. You can read about this project, <u>here</u>.
